MINUTES OF THE MEETING OF THE GENERAL ASSEMBLY HELD ON 11 DECEMBER 2020

The General Assembly of the Association was held at the head office by videoconference on 11 December 2020.

The General Assembly is chaired by Jürgen ROCKSTROH, President. The meeting secretary responsible for recording the minutes is Ann SULLIVAN.

The attendance list of the members present and represented at the General Assembly is attached to the minutes.

After having checked the proxies, the President opens the meeting at 11:00 am.

Welcome from the President, approval of the agenda:

The President welcomes the members and opens the General Assembly. The President recalls the agenda to the General Assembly.

After deliberation, respecting the quorum and the majority of votes provided for in the Articles of Association, the General Assembly decided to approve the agenda.

President's report:

Jürgen ROCKSTROH reviews the highlights and various activities of the year.

He notes that despite a difficult year 2020 due to the global pandemic, the Association has been active and managed to continue its education programme. He introduced and congratulated the new fellows of the Medical Exchange Programme. In 2020, EACS participated in scientific conferences and engaged in meetings organised, for example, by ECDC and WHO. EACS also continued its collaboration with stakeholders and endorsed various scientific activities. The Association published newsletters providing



guidance on COVID-19 for people living with HIV, in collaboration with BHIVA, DAIG, GESIDA and the Polish Scientific Association on AIDS. The Association has also implemented new activities, such as its participation in the EU Health Policy Platform and is now part of the EU Civil Society Forum for HIV, viral hepatitis and tuberculosis. The Association is also more active in the field of social media.

The President underlined the commitment of the EACS Guidelines panel members who despite the pandemic managed to update a new version of the Guidelines.

He informed the assembly that the European AIDS Conference will be held from 27 to 30 October in London in a hybrid format and announced the good news that the Hector Stiftung Foundation will once again make an endowment for the best research paper in clinical and epidemiological medicine and another one in basic and translational science.

Election of the new Governing Board:

The President introduces the new members of the Governing Board chosen among the EACS members of their respective regions.

After deliberation, in compliance with the attendance quorum and by a majority of votes provided for in the Association's articles of association, the General Assembly decided to approve the election of the new members of the Governing Board for a four-year term from the 1st January 2021.
